Dear Mr. Hartig:

I interpreted your letter to mean that the company wished to cancel its certificate. If that is what you want, I can open a docket to cancel your certificate using your January 28th letter. I can make the effective date of the cancellation December 31, 2008, since the letter was postmarked by January 30, 2009, the due date of the 2008 Regulatory Assessment Fee (RAF). If, however, you want the certificate cancelled with a 2009 effective date, then the company would owe not only the 2008 RAF balance (the \$699.21) but also the 2009 RAF (\$700) for a total of \$1,399.21.
