
Dear Chairman McMurrian:

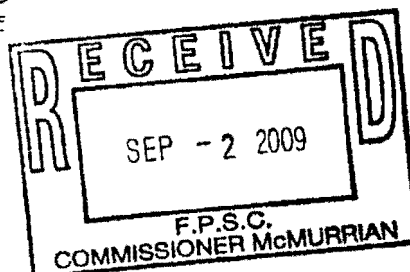
