# INTERCONNECTION, COLLOCATION AND RESALE AGREEMENT

This Interconnection, Collocation and Resale Agreement ("Agreement"), dated the 31st day of March, 2009, is entered into by and between T3 Communications, Inc., d/b/a Tier 3 Communications d/b/a Naples Telephone and d/b/a Fort Myers Telephone, a Florida corporation ("CLEC"), and Embarq Florida, Inc. ("Embarq"), a Florida corporation, which are collectively referred to herein as "the Parties", to establish the rates, terms and conditions for local interconnection, local resale and the purchase of unbundled network elements for the state of Florida.

NOW THEREFORE, the Parties agree as follows:

## 1. INTERCONNECTION, COLLOCATION AND RESALE AGREEMENT

The Parties agree that the Agreement between the Parties shall consist of the Kentucky Data Link Interconnection, Collocation and Resale Agreement dated the 24<sup>th</sup> of June, 2008 (the "Adopted Agreement").

All services provided under this Agreement will be consistent with the decisions of courts having jurisdiction over this Agreement, including but not limited to the decisions of the Court of Appeals and the United States Supreme Court.

#### 2. PARTIES:

CLEC is hereby substituted in the Adopted Agreement for Kentucky Data Link, whereas Embarq shall remain as the other Party to the Adopted Agreement. Except as modified herein, the Agreement shall in all other respects reflect the same terms as the Adopted Agreement.

#### 3. TERM:

This Agreement shall have a termination date of the 23<sup>rd</sup> of June, 2010, which corresponds with the termination date of the Adopted Agreement.

#### 4. NOTICES:

Except as otherwise provided, all notices and other communication shall be deemed to have been duly given when made in writing and delivered in person or deposited in the United States mail, by certified mailing, postage paid, and return receipt requested and addressed as follows:
