Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Ninth Notice of Intent to Request Confidential Classification of the information and documents produced in response to OPC's Sixth Set of Interrogatories (Nos. 64-72), specifically number 65 and 70, and OPC's Seventh Request for Production of Documents (Nos. 87-99), specifically numbers 89, 92, 94 and 96. The responses to these requests contain confidential and proprietary contractual information, as well as other confidential competitive business information, the release of which would harm PEF's competitive business interests. Furthermore, the release of this information would violate PEF's contractual confidentiality agreements.


