The Staff has requested that Silver Lake Utilities, Inc., provide a Status Report with regard to the eventual plant sites for serving the proposed Muse development.

An agreement for the Muse site, for the Environmental Resource Permit issued by the South Florida Water Management District has been entered into. It is expected that the project proposal will be submitted to the South Florida Water Management District Board in mid-year, 2010. The Dredge and Fill Permit issued by the U.S. Army Corp. of Engineers is underway. The local zoning and amendments to the Glades County comprehensive Plan have been approved.

Combined with the remaining State and Federal permitting issues, and the current market conditions that exist (at this point in time), the earliest that any anticipated ground breaking for the community would be estimated to be after mid-year, 2011.
