Dear Mr. O'Steen:

After reviewing the application filed in this docket, staff has identified the following deficiencies and additional information that is needed to complete the filing.

Deficiencies

1. Evidence must be provided that shows ownership by the Utility of the land where the plant is situated. See Rule 25-30.036(3)(d), Florida Administrative Code, (F.A.C.).
2. Provide numbers and dates of any permits issued to the Utility for the plant and/or distribution system by the Department of Environmental Protection. See Rule 25-30.036(3)(k), F.A.C.
3. Exhibit 6 includes a statement, rather than an affidavit, that the utility has tariffs and annual reports on file with the Commission. See Rule 25-30.046,(6)(q), F.A.C.
4. Noticing must be given as required by Rule 25-30.030, F.A.C. The Commission staff has historically interpreted this rule to require noticing to all customers of the Utility and not only those being deleted. See Rule 25-30.030(6), F.A.C.

Additional information

1. Please state when Neighborhood began serving the customers that were added as a result of the exchange in service territory with JEA.
2. Please state when JEA began serving the customers that were deleted as a result of the exchange in service territory with JEA.
