## Case Background

Heather Hills Estates Utilities, LLC (Utility) is a Class C water and wastewater utility serving approximately 354 water and wastewater customers in Manatee County. On August 16, 2010 the Commission approved a transfer of certificates from Keith & Clara Starkey d/b/a Heather Hills Estates to Heather Hills Estates Utilities, LLC. The Utility's 2009 Annual Report indicates that the Utility's operating revenue was \$48,523 for the water system and \$73,774 for the wastewater system.

On September 10, 2010, the Utility filed an application for approval of an increase in miscellaneous service charges for its water and wastewater operations. In addition, the Utility requested new after-hour charges. The Commission has jurisdiction pursuant to Section 367.091 Florida Statues (F.S.).
