(O&S or Utility) is a Class A water utility located in Osceola According to the Utility's 2009 Annual Report, it serves approximately 2,186 residential customers, 29 commercial customers, and 858 irrigation customers. O&S is in the South Florida Water Management District. The 2009 Annual Report reflected annual operating revenues of \$1,205,487 and net operating income of \$56,008.
