Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code., Progress Energy Florida Inc. (PEF) requests confidential classification of certain highlighted information on documents responsive to Staff's 9th Set of Interrogatories (Nos. 36-45) and Staff's 8th Request for PODs (Nos. 20-23), specifically interrogatory No. 43(b) and POD No. 23.
