BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), respectfully submits this Response to Request for Oral Argument filed by American Dial Tone, Inc. ("ADT").

AT&T Florida believes that the parties' pleadings adequately explain the parties' respective positions. Thus, AT&T Florida believes that oral argument is not needed. Moreover, AT&T Florida asserts that it has acted properly in enforcing the clear and unambiguous terms of the parties' ICA and that it is ADT, not AT&T Florida, that has placed ADT's customers in the position of having their service disconnected for ADT's actions in reselling residential service to an affiliated business entity, LifeConnex. To the extent that the Commission grants oral argument, AT&T Florida requests an opportunity to respond to any argument presented by ADT regarding its Request for Emergency Relief and Complaint.
