

SENIOR MANAGEMENT QUALIFICATIONS

Jonathan Kaufman, Managing Member

Jon Kaufman is currently the managing member of Network Billing Systems, LLC ("NBS") as well as CEO. of Interconnect Services Group (ISG). NBS was formed to become a national reseller providing long distance and related network services. Through prior experience, knowledge, and established contacts, Kaufman plans to build NBS into a premier respected long distance reseller.

ISG was formed in 1996 to be a back office service provider and to provide specialized platform services. 
