SECTION 63.71 APPLICATION OF INCLINE COMMUNICATIONS, INC.

Incline Communications, Inc. ("Incline") hereby seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, and 47 C.F. R. § 214 and Section 63.71 of the Commission's rules, 47 C. F. R. § 63.71, to discontinue its provision of domestic intrastate and interstate long distance telephone service in the state of Florida.

Incline is a reseller of intrastate and interstate long distance service and is considered to be non-dominant. Incline currently has no customers and has been actively pursuing a buyer for its assets and registrations with no success. Incline lost its customers due to competitive pricing it could not match and normal attrition. Incline has always maintained its ability to provide intrastate and interstate long distance service if requested to do so by a customer.

2. **Date of planned Discontinuance (47 C.F.R. §§ 63.71(a)(2) and (b)(2)):**

Incline plans to discontinue service on June 15, 2011 or as soon thereafter as any necessary regulatory approvals are obtained. Incline understands that this application will be automatically granted on the 31st day after public notice of filing unless the Commission notifies Incline to the contrary.

3. **Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3) and (b)(2)):**

Incline plans to discontinue the provision of resold intrastate and interstate long distance service in the state of Florida.

4. **Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4) and (b)(2)):**

Incline provided resold intrastate and interstate long distance service in the state of Florida.

5. **Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71(b)(3)):**

Incline does not have any customers receiving intrastate or interstate long distance in the state of Florida, therefore, a customer notice is not applicable. Incline lost its customers due to competitive pricing it could not match and normal attrition. Incline has always maintained its ability to provide intrastate and interstate long distance service if requested to do so by a customer.

6. **Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):**

Incline is non-dominant with respect to the intrastate and interstate long distance service that it proposes to discontinue.
