On October 27, 2011 I filed on behalf of Farmton Water Resources LLC an Application for Original Wastewater Certificate in the above-referenced docket. As a result of concerns raised by representatives of Volusia County, as outlined in their protest filed with the Commission dated November 28, 2011, the Utility has decided to remove, from the present application, all portions of the proposed service territory within Volusia County.

By copy of this letter, Farmton Water Resources LLC hereby restrictively amends its Application for Original Wastewater Certificate to exclude all lands in Volusia County from the proposed service territory.


