COMMISSIONER EDGAR: Thank you. 8 Mr. Chairman, I would move the staff 9 recommendation on Items 1, 6, 7, and 10. 10 CHAIRMAN BRISÉ: All right. Is there a 11 second? 12 COMMISSIONER BROWN: Second. 13 CHAIRMAN BRISE: It has been moved and 14 15 seconded. Any further comments? Commissioner Balbis. 16 COMMISSIONER BALBIS: Thank you, Mr. 17 Chairman. 18 Just briefly. I made some comments 19 yesterday, and Item 10 represents the inclusion of 20 those uprates into base rates, and I just want to point 21 22 out again that this represents over 500 megawatts of additional generation that in the first full year of 23 operation will save customers \$114 million in fuel 24 savings, and over the life of the projects over 25

\$3.8 billion in fuel savings. So I think this is a 1 good project and should be recognized that it is coming 2 on-line as expected. So with that I support the 3 motion. 4 COMMISSIONER BALBIS: All right. It has been 5 moved and seconded. 6 7 All in favor say aye. (Vote taken.) 8 CHAIRMAN BRISÉ: All right. Thank you. 9 Commissioner Edgar. 10 COMMISSIONER EDGAR: 11 Thank you. Mr. Chairman, Item 9, procedurally I would 12 like to ask that we reconsider the vote by which we 13 approved Item 1C in this docket previously. This is 14 purely for procedural reasons. It was a 4-0 vote, and 15 I was on the prevailing side. 16 CHAIRMAN BRISÉ: All right. Is there a 17 second? 18 COMMISSIONER BALBIS: Second. 19 CHAIRMAN BRISÉ: All right. It has been 20 moved and seconded. 21 22 Commissioner Brown. COMMISSIONER BROWN: Thank you.
