#### ADMINISTRATIVE RULES FILED WITH THE DEPARTMENT OF STATE

I hereby certify:

[x] (1) That all statutory rulemaking requirements of Chapter 120, F.S., and all rulemaking requirements of the Department of State have been complied with; and

[x] (2) That there is no administrative determination under Section 120.56(2), F.S., pending on any rule covered by this certification; and

[] (h) Are filed more than 90 days after the notice, but within 21 days after a good faith written proposal for a lower cost regulatory alternative to a proposed rule is submitted which substantially accomplishes the objectives of the law being implemented; or

[] (i) Are filed more than 90 days after the notice, but within 21 days after a regulatory alternative is offered by the Small Business Regulatory Advisory Committee.

(a) The address of the certificate holder's main corporate and Florida offices (if any) including street name

and address and post office box, city, state and zip code; or

(b) Telephone number, name, and address of the individual who is to serve as primary-liaison with the

Commission in regard to the ongoing Florida operations of the certificated company.

#### SUMMARY OF THE RULE

The Florida Legislature enacted the Regulatory Reform Act of 2011 which reduced requirements on telecommunication companies and provides for telecommunication companies to be treated similarly. Thus, separate rules are no longer needed for shared tenant service providers, as in Rule 25-24.585, F.A.C., and for competitive local exchange companies, as in Rule 25-24.835, F.A.C. Thus, these rules are being repealed.

#### WRITTEN STATEMENT OF THE FACTS AND CIRCUMSTANCES JUSTIFYING THE RULE

The rule repeals delete provisions that separately apply to shared tenant service providers and competitive local exchange companies in accordance with the Regulatory Reform Act of 2011.

#### SUMMARY OF ANY HEARINGS HELD ON THE RULE

No timely request for a hearing was received by the agency, and no hearing was held.
