**P R O C E E D I N G S**

2           **CHAIRMAN BRISÉ:** Before we move to our Move  
3 Staff, there's a couple of things that I need to say.

4           We want to take notice of Commissioner  
5 Brown's absence due to a medical procedure, and so we  
6 want to also keep her in our thoughts, as well.

7           On the Move Staff List we have on Item 1, the  
8 Consent Agenda, Item 1A there was a scrivener's error,  
9 in essence, when the notice went out. It said PAA, and  
10 it's supposed to be final action, so we wanted to take  
11 recognition of that at this time. It has been properly  
12 updated on the website and here in our agenda today.

13           So with that, we are prepared to move into  
14 the Move Staff, recognizing that there is going to be  
15 an oral modification to Items 6 and 7. And I think we  
16 will allow staff to do that at this time.

17           **MR. FLETCHER:** Commissioners, Bart Fletcher  
18 with Commission Staff.

19           On Items 6 and 7, under the noticing tariff  
20 and land ownership in the staff analysis, the  
21 modification that staff wishes to seek the Commission's  
22 indulgence on is to change "owns the land" to "has  
23 continued use of" for both Items 6 and 7.

24           **CHAIRMAN BRISÉ:** Okay. And I know that OPC  
25 had an interest in that, and I want to make sure that

1 the language is okay.

2 **MS. CHRISTENSEN:** Yes.

3 Commissioner, Patty Christensen with the  
4 Office of Public Counsel. We just wanted to make sure  
5 that that language was corrected, since they refer to  
6 easements, and make sure that the Commission was voting  
7 on the correct language.

8 **CHAIRMAN BRISÉ:** Okay. Thank you very much.

9 With that, Commissioner Edgar.

10 **COMMISSIONER EDGAR:** Thank you, Mr. Chairman.

11 I would move approval of staff recommendation  
12 for Item 1, as you described, Item 2, Item 3, Item 5,  
13 Item 6 as amended, Item 7 as amended, Item 9, Item 11,  
14 and Item 12.

15 **CHAIRMAN BRISÉ:** Okay. Thank you very much.

16 Is there a second?

17 **COMMISSIONER GRAHAM:** Second.

18 **CHAIRMAN BRISÉ:** Okay. It has been moved and  
19 seconded.

20 Any further comments?

21 All right. Seeing none, all in favor say  
22 aye.

23 (Vote taken.)

24 **CHAIRMAN BRISÉ:** All in favor say aye.


