SECTION 63.71 APPLICATION

Signal Point Corp. (hereinafter "SPC"), in accordance with Section 63.71 of the Federal Communications Commission's ("Commission") rules, hereby requests authority to discontinue the provision of certain domestic telecommunications services nationally. In particular, SPC proposes to discontinue provision of residential and small business retail and wholesale interconnected VoIP services nationally. SPC's is not relinquishing its domestic authority; it is merely terminating these services.

In support of this application, SPC submits the following, pursuant to 47 C.F.R.

§63.71(b):

1. The Applicant's name and address are:

2. The date of the planned service discontinuation is June 30, 2013 for reseller/wholesale services and July 7, 2013 for retail services, or as soon thereafter as necessarily regulatory approvals can be obtained.
3. The geographic area of service affected is nationally.

4. SPC currently provides service to approximately 800 residential and small business customers in the United States, who would be affected by the proposed discontinuance. SPC provides services to approximately 30 resellers nationally as well.
5. The discontinuance of service proposed in this Application is limited to SPC's stagnant, yet small, line of business that is no longer the principal focus of its larger business objectives. It is no longer economically viable for it to serve the retail and wholesale interconnected VoIP business, because of shrinking profitability and higher costs of administration. Moreover, these customers will have other outlets as Vonage and similar companies provide competitive Interconnected VoIP services and customers are increasingly choosing intermodal competition choices with attractive "bundles" like Verizon's Fios service. SPC has made arrangements with International Global Opportunity Network, L.L.C. d/b/a IGONET, a Delaware limited liability company, which has agreed to service any retail customers porting to them at the customer's current SPC rate should the customer decide to move to IGONET.
6. RNK initially sent notification to affected reseller customers via first class U.S. Mail on May 23, 2013 and electronic mail ("Reseller Notice").¹ A copy of the Reseller Notice is attached as **Exhibit A**. Retail customers were sent notification via first class U.S. Mail on June 7 and 8, 2013 and by electronic mail. A copy of the Retail Notice is attached as **Exhibit B**.
7. In accordance with 47 C.F.R. §63.71(a), a copy of this application is being sent to the to the governor and public utilities commission for each impacted state and the District of Columbia, and also to the Special Assistant for Telecommunications to the Secretary of Defense. A certificate of service pertaining to the aforementioned customer notices and

8. SPC is considered non-dominant with respect to the services to be discontinued.

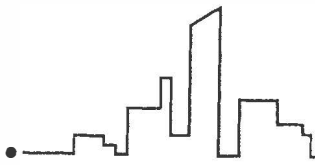

If no action is taken, when the interconnected VoIP phone services will be discontinued, your service will no longer work and customers will lose their telephone number.

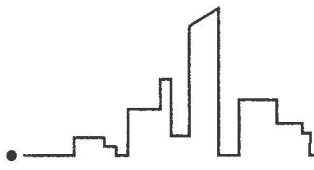
