Pursuant to Order No. PSC-93-0705-FOF-EU, which approved the territorial agreement between Florida Power & Light Company (FPL) and Lee County Electric Cooperative, Inc. (LCEC), we are jointly notifying the Commission of a situation where FPL is currently serving a customer that FPL and LCEC have recently concluded is actually within the LCEC service territory. During the week of July 15, 2013, LCEC notified FPL that it had discovered that FPL was serving a commercial building (with 3 customers) located within LCEC's service territory. FPL's investigation concluded that, in fact, the boundary line jogs one block west of where FPL originally thought the boundary line resided and the identified location is therefore within LCEC's service territory. FPL's service to the affected location was initiated in 2005. FPL and LCEC are not aware of any other similarly affected locations/customers in this area. FPL and LCEC agree that these customers should be transferred to and served by LCEC.

The necessary engineering/construction for transferring these customers is limited in scope (e.g., FPL must remove 3 poles and a transformer and LCEC must install 9 poles and a transformer). We expect the transfer to be complete before the end of November 2013, barring any unforeseen circumstances. Each utility will bear its own costs associated with the transfer. FPL will contact and inform the affected customers within the next several weeks, before any of the field work for the transfer begins. The affected customers will not be asked to reimburse any costs associated with completing the transfer.
