NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE OF AUTHORITY

BY THE COMMISSION:

Atlantic Broadband Enterprise (Miami), LLC (Atlantic Broadband) applied for a Certificate of Authority to provide Telecommunications service, pursuant to Section 364.335, Florida Statutes (F.S.) Upon review of the application, it appears that Atlantic Broadband has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant to Atlantic Broadband Certificate of Authority No. 8845, which shall authorize Atlantic Broadband to provide telecommunications services throughout the State of Florida.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, F.S., Certificate of Authority holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAF Return notice will be mailed each December to Atlantic Broadband for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Atlantic Broadband from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Atlantic Broadband's certificate. Atlantic Broadband shall retain this Order as proof of its certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.336, F.S.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Atlantic Broadband Enterprise (Miami), LLC's application for a Certificate of Authority is hereby granted. It is further

ORDERED that Atlantic Broadband Enterprise (Miami), LLC is awarded Certificate of Authority No. 8845, which authorizes Atlantic Broadband Enterprise (Miami), LLC, to provide telecommunications service throughout the State of Florida, subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order shall serve as Atlantic Broadband Enterprise (Miami), LLC's certificate and shall be retained by Atlantic Broadband Enterprise (Miami), LLC, as proof of certification. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.
