Item Number 9 is a petition from the Florida Division of Chesapeake Utilities Corporation seeking approval for the assumption of a special contract between Peninsula Pipeline Company and JDC Development for firm natural gas transportation service. The contract has an initial term of two years, with a feature of one-year extensions annually thereafter at the option of the parties.

The Petitioner submitted supporting documentation, including a cost of service study, and also provided additional cost information in response to data requests from staff.

Based on review of the documentation provided, staff believes that the contract rates adequately cover the cost to serve the customer and also provide a contribution to Chesapeake's common costs. Assumption of the contract would benefit the parties and will not impose additional costs on Chesapeake's other ratepayers.
