AT&T FLORIDA’S MOTION FOR EXPEDITED APPROVAL

BellSouth Telecommunications, LLC d/b/a AT&T Florida (“AT&T Florida”), pursuant to Rule 28.106-204,¹ Fla. Admin. Code, moves the Commission for expedited approval of the Interconnection Agreement (ICA) between AT&T Florida and Local Access, LLC (“Local Access”) filed September 17, 2013.

AT&T Florida and Local Access entered into an Interconnection Agreement on April 30, 2013. Due to an administrative oversight, there was a delay in the filing of the ICA until August 28, 2013. AT&T Florida electronically submitted the ICA for approval by the Commission on August 28, 2013. However, there was an error in the electronic submission of the filing which caused the Commission’s electronic filing system to reject the filing and an electronic rejection message was returned to AT&T Florida. The rejection message was overlooked and not discovered until September 16, 2013. Upon discovery of the error, the ICA was promptly electronically re-filed.

Under typical circumstances, ICAs are submitted to the Commission within 60 days after entering into the ICA. Under the Commission’s internal process, once an ICA is submitted for approval the Commission provides a 90-day period to allow the Commission to address any objection to the approval of the ICA. If no objection is received, the ICA is deemed approved by operation of law after the 90th day from filing. *See* 47 U.S.C. § 252(e)(4).

¹ As required by Rule 28-106.204(3), AT&T Florida has consulted with counsel for Local Access and AT&T Florida is authorized to represent that they do not object to the relief sought by the instant Motion.

Based on a typical ICA submission and approval process, Local Access expected that it would be able to begin operations under the new ICA beginning in September 2013. To accommodate Local Access's expectations, AT&T Florida requests that the Commission expedite its approval of the ICA between AT&T Florida and Local Access.

Based on the foregoing, AT&T Florida respectfully requests that the Commission expedite the approval of the parties' interconnection agreement.
