2 **CHAIRMAN BRISÉ:** Moving on to Item Number 6.

3 **MS. L'AMOREAUX:** Good morning, Commissioners.

4 Melissa L'Amoreaux with staff.

5 Item 6 is staff's recommendation regarding the
6 updated storm hardening plans of Duke Energy Florida,
7 Florida Public Utilities Company, Florida Power and
8 Light, Tampa Electric Company, and Gulf Power Company.

9 Rule 25-6.0342, also known as the storm
10 hardening rule, requires all Florida investor-owned
11 utility companies, or IOUs, to file updated storm
12 hardening plans every three years with the Commission.
13 This recommendation addresses the IOU's planned updates
14 as required by the storm hardening rule, and staff
15 recommends that the Commission approve all five
16 investor-owned utilities' plans. Staff is available for
17 any questions.
