25-17.003: Energy Audits

PURPOSE AND EFFECT: To delete obsolete references and repeal requirement for information to be filed with the Commission that is no longer necessary.

Docket No. 130257-EI

SUMMARY: The amendments remove obsolete references in subsection (2)(a) of Rule 25-17.003, F.A.C. The rules mentioned in the subsection have been repealed and they should not be listed. The amendments also delete a requirement in subsection (5)(a) which required that a utility file annually with the Commission a certification that each of its residential energy auditors meet minimum qualifications along with a list of auditors performing energy audits. This submission of the information is unnecessary because it has not been used by the Commission or outside entities.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has been prepared by the agency.

The SERC examined the factors required by Section 120.541(2)(c), FS, and concluded that the rule amendments will not have an adverse impact on economic growth, business competitiveness, or small business and that there would likely be cost savings to the affected utilities required to comply with the rule.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: based upon the information contained in the SERC.

Any person who wishes to provide information regarding a statement of estimated regulatory costs, or provide a proposal for a lower cost regulatory alternative must do so in writing within 21 days of this notice.
