



NI FLORIDA CUSTOMER NOTICE

Section 367.0816, Florida Statutes, requires that rate case expense be recovered over a period of four years. The statute further requires that the rates of the utility be reduced immediately at the conclusion of the four years by the amount of rate case expense previously included in the rates.

Ni Florida, LLC. was granted a rate increase by the Florida Public Service Commission in Order No. PSC-10-0168-PAA-SU, issued on 3/23/2010 in Docket No. 090182-SU. The four-year recovery period for rate case expense expired on 04/26/2014. Effective July 10, 2014, the rates will be reduced as follows:
