 the affected services on or around April 30, 2015, or as soon thereafter as any necessary
 regulatory approvals are obtained.
- Points of Geographic Areas of Service Affected: Applicant proposes to discontinue the affected services throughout the United States. The affected services are not

currently provided in Alaska, Hawaii, North Dakota, South Dakota and Utah. The affected services are not offered in offshore U.S. locations.

- 4. <u>Description of Service Affected</u>: The affected services include the following:
 - (a) <u>Carrier Toll-Free PIN</u>: A service that provides carrier customers with a shared toll-free number and personal identification numbers ("PINs") that may be pre-programmed for termination to any domestic telephone number. The customer is billed for the calls rather than the call originator.
 - (b) <u>Carrier 700 Number PIC Verification</u>: A service that enables carrier customers to provide their end-user customers with a 700 number to call to verify that their presubscribed long-distance carrier has been changed.
- 5. <u>Brief Description of the Dates and Methods of Notice to All Affected</u>

 <u>Customers</u>: Applicant sent a written notification of the planned discontinuance by overnight delivery service on March 18, 2015, to customers utilizing the services in accordance with Section 63.71(a) of the Commission's Rules.
- 6. Whether the Carrier is Considered Dominant or Non-dominant with

 Respect to the Service to be Discontinued: Applicant is considered non-dominant with respect to the services to be discontinued.
- 7. Other Information: In accordance with Section 63.71(a) of the Commission's Rules, a copy of this application is being mailed concurrently with its filing to the governors and public utility commissions of all U.S. states (except Alaska, Hawaii, North Dakota, South Dakota and Utah, where the affected services are not provided) and the District of Columbia, and to the Special Assistant for Telecommunications to the Secretary of Defense.
