IN The PAST SEVENTEEN YEARS WE have had three different water Companies without any Complaints until charlie CREEK UTILITIES TOOK OVER.

OUR Objections ARE AS Follows

- 1. Higher bills FOR LESS SERVICE.
- 2. I have had a NOTICE ON MY dOOR THAT WE could USE OUR WATER THE boil WATER NOTICE WAS OVER, WE had NEVER RECEIVED A boil WATER NOTICE IN THE FIRST PLACE.
- 3. WE NEVER DEFORE HAD GONE MORE THAN FOUR OR FIVE HOURS days with NO WATER. WITH This Company WE have GONE THREE
- 4. The water does not seem to be getting treated. We used to Smell chlorine in the water when they would treat the water about once a month. We never smell chlorine any more. We only smell a repulsive goof sulfer. I have never before smelled sulfer in the water for seventeen years.

I NOW buy WATER TO DRINK, COOK, AND do MY LAUNDRY ELESWHERE, AND PAY MORE FOR WATER I CANT USE. (20F2)

5. Customer service is very bad with Charlie Creek util LLC, A real Nice receptionist takes your calls and tells you whatever you want to hear, but nothing is ever done, We have made at Least Seven calls about the smell of the water, and calls about the hole at end of mocking bird Road. There is a break in the Line and has been bubbling and washing out the Road. This is the fix that had us down for 3 days prior, wonder how Long it will be this time. They did come and put three Orange Stakes, 90 cars would not fall in it. The next day the Hardee County Road and crew came and put up barricades because the orange stakes were inadequate,
