**UPDATE:** *OUR WATER IS SAFE TO DRINK! Pasco Utilities Director Flip Mellinger is working daily with Utilities, Inc. of Florida and Tampa Bay Water on a permanent solution to reduce the increased flushing we have had since the December 21, 2016 interconnect with county water. We have been assured by Patrick Flynn, UIF VP and Pasco Utility Director Mellinger that Summertree will NOT be charged for the flushing. The county may need to install some equipment on SR 52 to stabilize the chloramine residuals to reduce flushing at no cost to Summertree. For all other issues please contact the PSC or UIF Customer Service daily, if needed.*
