**APPLICATION FOR APPROVAL OF NEW CLASS OF SERVICE
FOR PRIVATE FIRE PROTECTION SERVICE**

LITTLE GASPARILLA WATER UTILITY, INC. (“Utility”), by and through its undersigned attorneys, pursuant to Chapter 367.091, Florida Statutes, Chapter 25-9, and Rules 25-30.135 and 25-30.465, Florida Administrative Code, requests the Florida Public Service Commission (“Commission”) to authorize the Applicant to establish a new class of service and approve its Private Fire Protection Service Tariff:

- (3) Hideaway Bay Beach Club Condominium Association, Inc. has requested that the Utility provide private fire protection service to its condominium building located on Little Gasparilla Island (see letter attached hereto as Exhibit “A”). The Utility does not have any private fire protection customers and therefor does not have an approved Private Fire Protection Service

rate. Rule 25-30.465, Florida Administrative Code, sets a “default” private fire protection service rate at 1/12th of the current base facility charge unless the Utility justifies some other rate.

(4) The Utility proposes rates consistent with the “default” rate in Rule 25-30.465, F.A.C., and attached hereto as Exhibit “B” is Original Sheet No. 13.1.

(5) Pursuant to Section 367.091(5), Florida Statutes, the Utility will implement this new class of service upon the connection of the Hideaway Bay Beach Club Condominium Association, Inc.’s fire line to the Utility’s main.

WHEREFORE, LITTLE GASPARILLA WATER UTILITY, INC., requests (1) that the Commission approve the approve a new class of service for private fire protection service; and (2) that the Commission approve the attached water tariff sheet implementing this new class of service.
