2 CHAIRMAN GRAHAM: Good morning. Let's try
3 that again. Good morning.

4 (Chorus from audience: Good morning.)

5 CHAIRMAN GRAHAM: There we go.

8 Jimmy Patronis, our former -- CFO, and he says that

14 She will be greatly missed, and her
15 contribution to the Commission, I think, should not
