In an effort to ensure a smooth transition for all involved with the Area Code Relief Projects in Florida, and after evaluating remaining available numbering resources, the Industry Committee proposes extending the 7 or 10-digit Permissive Dialing Periods for the 813 and 850 NPAs. Our proposed implementation schedule is as follows:

## 850/448 NPA

The industry test number: 448-448-1448. The test number will be active 3/22/2021 through 07/22/2021 (revised).

850/448 NPA	DATE
End of permissive dialing and start of mandatory 10-digit dialing	May 22, 2021 (revised)
Earliest new 448 NPA central office code activation / in service date	June 22, 2021 (revised)
Earliest date central office codes in the new 448 overlay area may be ordered through NANPA*	April 17, 2021 (revised)

We recognize the delays that certain security and alarm companies are incurring due to limited building access caused by the COVID-19 pandemic, and the potential public safety risk that could result by such delays. The Industry Committee is confident that the extended Permissive Dialing Periods will provide these companies, and all involved with the NPA overlays, appropriate time to properly implement the requirements.

The Industry Committee kindly requests a prompt issuance of the Commission's decision in order to provide adequate preparation time for January 2021 customer communications reflecting the revised 850/448 mandatory dialing date.
