

FAR NOTICE OF PREHEARING AND HEARING

PUBLIC SERVICE COMMISSION

The FLORIDA PUBLIC SERVICE COMMISSION announces a prehearing conference and a hearing in the following docket to which all persons are invited.

DOCKET NO. AND TITLE: Docket 20200172-EI – Petition for evaluation of Hurricane Dorian storm costs, by Florida Power & Light Company.

PREHEARING CONFERENCE DATE AND TIME: Monday, February 1, 2021, starting at 1:00 p.m.

PLACE: Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE PREHEARING:

The purpose of this prehearing conference is to: (1) simplify the issues; (2) identify the positions of the parties on the issues; (3) consider the possibility of obtaining admissions of fact and of documents which will avoid unnecessary proof; (4) identify exhibits; (5) establish an order of witnesses; and (6) consider such other matters as may aid in the disposition of the case.

HEARING DATE AND TIME: Tuesday, February 23, 2021, starting at 9:30 a.m. and continuing on February 24, 2021 if necessary.

PLACE: Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING: The purpose of this hearing is for the Florida Public Service Commission to take evidence upon which it will take final action to determine the reasonable and prudent Hurricane Dorian storm costs to be recovered from ratepayers. This proceeding shall: (1) allow FPL to present testimony and other evidence in support of its petition; (2) permit any intervenors to present testimony and other evidence concerning the petition; and (3) allow for such other proceedings relevant to the proposed decommissioning as the Commission may deem appropriate. All witnesses shall be subject to cross examination at the conclusion of their testimony.

Interested persons may also request to be listed as an interested person for this docket, in which case they will receive notices and orders published and issued in the docket. The hearing will be governed by the provisions of Chapters 120 and 366, F.S.; and Chapters 25-22, 28-106, and 28-109, F.A.C.
