## NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING TRANSFER OF CERTIFICATE OF AUTHORITY NO. 8360

## BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission (Commission) that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On December 14, 2020, Spectrotel of Florida LLC d/b/a Touch Base Communications (Touch Base) filed with this Commission an application for approval of transfer of Certificate No. 8360 from Spectrotel, Inc. d/b/a OneTouch Communications d/b/a Touch Base Communications. Upon review of the application, it appears Touch Base has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby approve the transfer of Certificate of Authority No. 8360¹ to Touch Base and thereby authorize Touch Base to provide telecommunications service.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, F.S., and Chapter 25-4, F.A.C.

In addition, under Section 364.336, F.S., certificate holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAF Return notice will be mailed each December to Touch Base for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Touch Base from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Touch Base's certificate. Touch Base shall retain this Order as proof of its certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.336, F.S.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Spectrotel of Florida LLC d/b/a Touch Base Communications' application for transfer of Certificate No. 8360 is hereby granted. It is further

ORDERED that Spectrotel of Florida LLC d/b/a Touch Base Communications is authorized to provide telecommunications service, subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order shall serve as Spectrotel of Florida LLC d/b/a Touch Base Communications' certificate and shall be retained by Spectrotel of Florida LLC d/b/a Touch Base Communications, as proof of certification. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.
