Good afternoon all. Below is a link to the latest Seminole County plan set for the EE Williamson Trail and Longwood Sidewalk Project. We appreciate your patience as this project has progressed. It has been some time since we have communicated with you regarding the project, your existing utilities and proposed relocations. Much has occurred since the 100% plans were distributed but I believe the plan set in the link below to be the final plan set. The County is in the process of acquiring or has acquired additional ROW in some areas and these changes may have an affect on your relocation plans. They have eliminated a small portion of work west of Interstate 4 and have made changes to a few

curb inlets. The County plans to start the bidding process early January 2021. That process should take a few months with construction to start second half of 2021.

We ask that you review the plan set and your original Generic Utility Work Schedule (UWS), and submit 1) your RGB mark ups on the below referenced plan set and 2) UWS by December 18. This way the County and bidders can be assured of necessary utility activity and your utility facilities are well known to the bidders. A Generic UWS is attached for your use.

If you are no longer the appropriate contact for your utility on this project please forward this message to the appropriate contact and copy me so that we are aware of any changes.

We note that in original reviews AT&T Transmission and Seminole County Water/Sewer/Reclaimed Water were clear of the project area. Due to the time that has passed and ever changing construction please confirm that is still true or submit RGB mark ups and a UWS.
