NOTICE IS HEREBY GIVEN THAT the FLORIDA PUBLIC SERVICE COMMISSION has issued an order disposing of the petition for declaratory statement filed by TruConnect Communications, Inc. on December 23, 2020. The following is a summary of the agency's disposition of the petition:

The agency issued a declaratory statement that the Florida Public Service Commission cannot and will not assert jurisdiction over TruConnect Communications, Inc. for the sole purpose of Lifeline-only ETC designation because TruConnect Communications, Inc. is a commercial mobile radio service provider exempted from the Florida Public Service Commission's jurisdiction under Sections 364.011(4), 364.02(13)(c), and 364.10, F.S. Order No. PSC-2021-0103-DS-TP was issued and filed on March 12, 2021, in Docket No. 20200260-TP.
