#### PURPOSE AND PROCEDURE:

The purpose of this hearing is for the Florida Public Service Commission to take evidence upon which it will take final action to determine whether the Stipulation and Settlement dated March 9, 2021, regarding Hurricane Dorian storm costs to be recovered from Florida Power & Light Company's ratepayers is in the public interest. This proceeding shall: (1) allow Florida Power & Light Company to present testimony and other evidence in support of the Stipulation and Settlement; (2) permit any intervenors to present testimony and other evidence concerning the Stipulation and Settlement; and (3) allow for such other proceedings relevant to the proposed Stipulation and Settlement as the Commission may deem appropriate.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the Stipulation and Settlement. All witnesses shall be subject to cross-examination

at the conclusion of their testimony.

Interested persons may also request to be listed as an interested person for this docket, in which case they will receive notices and orders published and issued in the docket. Accordingly, the hearing will be conducted remotely, and all parties and witnesses shall be prepared to present argument and testimony by communications media technology. The Public Service Commission shall act as the host of the hearing and will use a combination of technologies to ensure full participation. The Commission will employ GoToMeeting as an audio and video platform for the hearing, and will provide for simultaneous, audio-only participation by telephone.

A GoToMeeting invitation shall be provided to counsel for each party. It shall be the responsibility of counsel to provide their clients, client representatives, and witnesses with the invitation, which will allow them to access the hearing. Counsel for each party will also be provided the call-in number for audio participation.

Any member of the public who wants to observe or listen to the proceedings may do so by accessing the live video broadcast the day of the hearing, which is available from the FPSC website. Upon completion of the hearing, the archived video will also be available.

#### JURISDICTION

The hearing will be governed by the provisions of Chapters 120 and 366, F.S.; and Chapters 25-22, 28-106, and 28-109, F.A.C.
