PURPOSE AND PROCEDURE

The purpose of these service hearings shall be to give customers and other interested persons an opportunity to offer comments regarding the quality of service the utilities provide and the proposed rate increase. One or more of the Commissioners of the Florida Public Service Commission may attend and participate in this meeting. The procedure at these hearings shall be as follows: The Company will present a brief summary of its case and then members of the public may present testimony. The Office of Public Counsel and other intervenors will also be allowed to make an opening statement or presentation.

These customer service hearings will be conducted virtually. The Commission shall act as the host of these hearings and will use a combination of technologies to ensure full participation. The Commission will employ GoToMeeting as an audio and video platform for the hearing, and will provide for simultaneous, audio-only participation by telephone. Persons wishing to testify will present their testimony over the telephone.

A GoToMeeting invitation shall be provided to counsel for each party. It shall be the responsibility of counsel to provide their clients with the invitation, which will allow them to access the hearing. Counsel for each party will also be provided the call-in number for audio participation.

All witnesses shall be subject to cross examination at the conclusion of their testimony. Customers who wish to speak in Spanish are encouraged to select a hearing at which an interpreter will be available.
