INSTEAD, I WOULD SUGGEST YOU LOOK TO USE SOME OF YOUR CAPITAL SURPLUS (OVER \$11 BILLION AS OF 3/31/21) OR RETAINED EARNINGS (OVER \$26 BILLION AS OF 3/31/21). YOU NEED TO SPEND/INVEST MONEY LIKE YOUR CUSTOMERS DO - EARN IT FIRST, THEN USE IT, OR ELSE TAKE ON DEBT (WITH HISTORICALLY LOW INTEREST RATES AND A STRONG CREDIT RATING, YOU SHOULD BE ABLE TO BORROW MONEY FOR NEXT TO NOTHING.) YOUR CUSTOMERS ARE NOT A BANK.
