Frontier Communications of the South, LLC, herein after referred to as (“Frontier”) hereby files the enclosed affidavit. This affidavit is being given to support the Florida Public Service Commission’s certification as contemplated in 47 C.F.R. § 54.314.

Frontier requests the Florida Public Service Commission to file the annual certification regarding federal high-cost support with USAC and the Federal Communications Commission, pursuant to 47 CFR 54.314(a).

The amount of federal high-cost Frontier will receive in 2022 will continue to be used for the services and functionalities outlined in 47 C.F.R. §54.314 and, as the attached affidavit shows, Frontier certifies that it will only use the federal high-cost support it receives for the provision, maintenance and upgrading of facilities and service for which such support is intended.

Frontier certified and filed a copy of its FCC Form 481 annual report once it is filed with the Universal Service Administrative Company (USAC) on June 17, 2021 in compliance with 47 CFR § 54.313 and 47 CFR § 54.422. Section 54.313 applies to an eligible telecommunications carrier (ETC) receiving high-cost federal USF support. Section 54.422 applies to ETCs receiving low-income support.

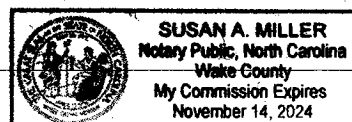
