# SECTION 63.71 APPLICATION OF XO COMMUNICATIONS SERVICES, LLC

XO Communications Services, LLC ("XO"), submits this Application under Section 214(a) of the Communications Act and Section 63.71 of the Commission's rules to discontinue Switched Access IP Direct Connect service (the "Affected Service"). XO plans to discontinue the Affected Service on or after August 30, 2021, in 26 states and the District of Columbia (see Section 3 below for the specific states). While XO offers the Affected Service to both retail and wholesale customers, XO has no current retail customers and just three remaining wholesale

customers on the Affected Service.<sup>3</sup> The Affected Service is not plain old telephone service ("POTS").

Consistent with Section 63.71(a) and (c) of the Commission's rules, XO provides the following information:

#### 1. Name and Address of Carrier (47 C.F.R. §§ 63.71 (a)(1), (c)(2)):

XO Communications Services, LLC One Verizon Way Basking Ridge, NJ 07920

#### 2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (c)(2)):

Subject to the Commission's authorization, XO will discontinue the Affected Service on or after August 30, 2021.

#### 3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (c)(2)):

Subject to the Commission's authorization, XO will discontinue the Affected Service in the District of Columbia and the following 26 states: Arizona, California, Colorado, Delaware, Florida, Georgia, Idaho, Illinois, Maryland, Massachusetts, Michigan, Minnesota, Mississippi,

Missouri, Nevada, New Jersey, New York, North Carolina, Ohio, Oregon, Pennsylvania, Tennessee, Texas, Utah, Virginia, and Washington.

4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), (c)(2)):

XO seeks to discontinue:

Switched Access IP Direct Connect Service: Switched Access IP Direct Connect is a service that allows for IP traffic termination to the XO network and its retail business customers. XO provides Switched Access IP Direct Connect between the customer's equipment and XO Local Switching Center switch(es); the customer separately purchases an IP interconnection service to access the Switched Access IP Direct Connect Service. Switched Access IP Direct Connect Service is provided to customers for which XO has installed a gateway or gateways (the "Gateway") that will allow IP traffic to terminate to XO's switched network and includes connectivity from the Gateway to XO's private IP network via a dedicated connection. The service allows voice and call set-up signaling to be carried from the Gateway to XO's switched network for termination by XO's local switches.

The Affected Service represents only about 7% of the traffic that is routed to XO's IP network.

Alternative Services and Products: Customers of the Affected Service may terminate IP traffic directly on XO's network pursuant to a commercial agreement or indirectly through agreements with other providers, such as Verizon Business, that terminate traffic to XO's network.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71 (c)(3)):

Customers of the Affected Service were sent notices by U.S. mail on or before June 28, 2021. A copy of the notice is attached as Exhibit A.

Separately, on or before June 28, 2021, copies of this Application were sent by U.S. mail to the governor and public utilities commission of each affected state, to federally-recognized tribal nations in each affected state, and to the Department of Defense Chief Information Officer, as required by Section 63.71(a) of the Commission's rules.

6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(c)(4)):

XO is classified for regulatory purposes under the Commission's rules as non-dominant with respect to the service to be discontinued.

#### CONCLUSION

XO respectfully requests that the Commission approve this Application.
