On June 17, 2021 pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida (DEF or Company) requested an extension of confidential classification for certain information contained in DEF's Response to Staff's Third Set of Interrogatories and Revised Exhibit D, Affidavit of Terry Hobbs, as appears in Document No. 10958-2019, filed on November 15, 2019.

On November 15, 2019, DEF filed the original Request for Confidential Classification related to this document. DEF's Request was granted by Order No. PSC-2019-0533-CFO-EI on December 19, 2019.

In the current request for extension, the Company maintains that nothing has changed such that the information in this document would no longer continue to be considered confidential under Sections 366.093(3)(d) and (e), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (d) "Information concerning the bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "Information relating to the competitive interests, the disclosure of which would impair the competitive business of the provider of the information."

Staff has reviewed DEF's Request for Extension for Confidential Classification and the information provided in DEF's Response to Staff's Third Set of Interrogatories and Revised Exhibit D, Affidavit of Terry Hobbs, as well as the Company's confidentiality request (Document No. 06125-2021). Staff believes that the information that is the subject of the confidentiality request meets the criteria for confidentiality contained in Section 366.093(3)(d) and (e), F.S. Staff recommends that the Company's request for extension of confidentiality of the highlighted information included in Document No. 10958-2019, be approved.
