Please provide more detailed breakdowns of Exhibit (JAA-1) (i.e. including capital, which is provided in petition, the weighted average cost of capital, depreciation, and any other O&M, e.g., property taxes, and the Net Operating Income multiplier/revenue expansion factor used) in electronic/spreadsheet format (MS Excel, cells unlocked and formulas intact) for the Third Solar Base Rate Adjustment.
