FLORIDA POWER & LIGHT COMPANY'S PRELIMINARY LIST OF ISSUES AND POSITIONS

Florida Power & Light Company ("FPL"), representing the merged and consolidated operations of FPL and the former Gulf Power Company ("Gulf"), by and through its undersigned counsel, hereby submits this Preliminary List of Issues and Positions to Order Nos. PSC-2021-0075-PCO-EG and PSC-2021-0280-PCO-GU.

ISSUE 1: What are the final conservation cost recovery adjustment true-up amounts for the period January 2020 through December 2020?

FPL: FPL's final conservation cost recovery adjustment true-up amounts for the period of January 2020 through December 2020, is an over-recovery of \$2,529,096. Gulf's final conservation cost recovery adjustment true-up amounts for the period of January 2020 through December 2020 is an under-recovery of \$226,949. (FPL witnesses Deaton and Floyd)

<u>ISSUE 2</u>: What are the appropriate conservation adjustment actual/estimated true-up amounts for the period January 2021 through December 2021?

FPL: FPL's conservation adjustment actual/estimated true-up amounts for the period of January 2021 through December 2021, including interest, is an over-recovery of \$9,673,286. Gulf's conservation adjustment actual/estimated true-up amount for the period of January 2021 through December 2021, including interest, is an over-recovery of \$1,748,223. (FPL witnesses Deaton and Floyd)

¹ Effective January 1, 2021, Gulf and FPL were legally merged with FPL being the surviving entity. On January 11, 2021, pursuant to Rule 25-9.044, F.A.C., FPL submitted a notice of the change in ownership of Gulf effective January 1, 2021, and FPL's adoption and ratification of Gulf's existing rates and tariff on file with the Commission. FPL is representing the merged and consolidated operations of FPL and the former Gulf. "Gulf," as used in this Petition, has reference to the former Gulf Power Company and/or Gulf as the separate ratemaking entity for purposes of this Petition and the application of the ECCR rules and plan, as context would dictate.

<u>ISSUE 3</u>: What are the appropriate total conservation adjustment true-up amounts to be collected/refunded from January 2022 through December 2022?

FPL: FPL's total conservation adjustment true-up amounts to be refunded from January 2022 through December 2022 is \$12,202,382. Gulf's total conservation adjustment true-up amounts to be refunded from January 2022 through December 2022 is \$1,521,274. (FPL witnesses Deaton and Floyd)

ISSUE 4: What are the total conservation cost recovery amounts to be collected during the period January 2022 through December 2022?

FPL: Subject to and contingent upon the Commission's approval of FPL's pending request for unified rates in Docket No. 20210015-EI, the total costs associated with the consolidated ECCR programs projected to be incurred between January 1, 2022 and December 31, 2022, are \$156,246,950. (FPL witness Floyd)

In the event that the Commission declines to approve FPL's pending request for unified rates in Docket No. 20210015-EI, the total costs associated with the consolidated ECCR programs projected to be incurred between January 1, 2022 and December 31, 2022, are \$148,581,164 for standalone FPL and \$9,437,988 for standalone Gulf. (FPL witness Floyd)

ISSUE 5: What are the conservation cost recovery factors for the period January 2022 through December 2022?

FPL: Subject to and contingent upon the Commission's approval of FPL's pending request for unified rates in Docket No. 20210015-EI, the appropriate FPL unified factors for the period January 2022 through December 2022 are:

<u>ISSUE 6</u>: What should be the effective date of the new conservation cost recovery factors for billing purposes?

FPL: The factors shall be effective for meter readings that occur on or after January 1, 2022. These charges shall continue in effect until modified by subsequent order of this Commission. (FPL witness Deaton)

ISSUE 7: Should the Commission approve revised tariffs reflecting the energy conservation cost recovery amounts and energy conservation cost recovery factors determined to be appropriate in this proceeding?

FPL: Yes. The Commission should approve revised tariffs reflecting the energy conservation cost recovery factors determined to be appropriate in this proceeding. The Commission should direct staff to verify that the revised tariffs are consistent with the Commission's decision. (FPL witness Deaton)

ISSUE 8: Should this docket be closed?

FPL: This docket is an on-going docket and should remain open. (FPL witness Deaton)
