Request for Confidential Classification of Document No. 08287-2021

On July 23, 2021, Peninsula Pipeline Company, Inc. (Peninsula or company) filed a request for confidential treatment for Document No. 08287-2021. This document contains confidential information from certain portions of the joint responses to staff's first data requests, Request No. 1. The confidential information contained relates to the cost estimates and the breakdown between labor and materials for each portion of the facilities Peninsula will construct, pursuant to the proposed firm transportation agreement.

In its request for confidentiality, Peninsula asserts that disclosure of this information would cause harm to both Peninsula and Florida Division of Chesapeake Utilities Corporation (Chesapeake) by impairing each companies' respective abilities to effectively negotiate for goods and services. Peninsula states that release of this information would also provide its competitors with an unfair advantage. Furthermore, Peninsula states that the both the company and Chesapeake treat the highlighted information provided in Document No. 08287-2021 as confidential.

Staff has reviewed the document and concurs with Peninsula that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair the competitive business operations of Peninsula. Therefore, staff recommends that the request by Peninsula for confidential classification of Document No. 08287-2021 be approved.
