The Company is claiming confidentiality of portions of Exhibit JJC-1 and JAA-1 under Sections 366.093(3)(d) and Section 366.093(3)(e), F.S. Per the Statute, proprietary confidential business information includes, but is not limited to: Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information provided for which confidential treatment is being sought can be described as bid related information for the Wimauma and Little Manatee River solar sites estimated and actual project costs provided in response to Tampa Electric's Request for information during contract negotiations with vendors.

Staff has reviewed the request for confidential classification. It is staff's opinion that the information that is the subject of this request meets the criteria for confidentiality contained in Sections 366.093(3)(d) and 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidential classification of the information be approved.
