Dear Mr. Teitzman:

Pursuant to Section 25-6.0424(2) of the Florida Administrative Code, Florida Power & Light Company ("FPL"), representing the merged and consolidated operations of FPL and the former Gulf Power Company, provides notice that a greater than ten percent under-recovery is now projected to occur compared to recovery under the fuel cost recovery factors submitted on September 3, 2021 to be implemented January 1 through December 31, 2022. This projection is based on current NYMEX settlement prices which have declined from an early September high, but remain volatile. Given the continuing volatility in the current natural gas market, FPL will defer by one month a decision regarding whether to file a petition for mid-course correction to its filed 2022 fuel cost recovery factors. FPL will reevaluate its fuel cost recovery position in October as part of its normal monthly process and will provide a further notice by October 15, 2021 based on that evaluation.
