North Florida Resiliency Connection (NFRC) 161 kV Transmission Line Submission and Review of the excavation/testing Management Summaries 09 March 2021 - **REVISED** 

Gulf Power Company (Gulf Power) has contracted with two cultural resources firms, Janus Research and SEARCH, Inc. to conduct the archaeological testing/data recovery efforts at the sixteen (16) archaeological sites along the NFRC Transmission Line corridor. This included evaluation of National Register of Historic Places (NRHP) eligibility at eleven (11) sites: 8GD21, 8GD2036, 8GD2270, 8JA2082, 8JE67, 8JE872, 8JE880/8LE1549, 8JE881, 8JE883, 8LE2102 and 8LE2105 per the Archaeological Site Testing Plans (ASTP) developed for these sites. Historic Properties Treatment Plans (HPTP) were developed and approved to resolve adverse effects on five (5) historic properties: 8LE2105, 8MD107, 8MD321, 8MD345 and 8SU422. In order to maintain the project construction schedule, testing and data recovery efforts at these sites have been sequenced in such a way that those that are to be constructed first are being evaluated first and those locations with later proposed construction dates were scheduled later in the order of construction priority. The field work began on 1 February 2021 and is scheduled to be completed by 23 April 2021. The proposed start and completion dates for testing along with the planned Management Summary submittal dates are provided in the table attached.

Once the initial fieldwork and preliminary artifact analysis is complete, the consultants will provide a brief (10-20 page) Management Summary. The Management Summaries will provide the consultant's recommendation on the adequacy of the data recovery effort or the need for additional testing should the level of effort proposed in the approved testing plan prove inadequate. For the eleven (11) sites subject to ASTPs, NRHP eligibility recommendations will also be made.

Gulf Power proposes to submit the Management Summaries to the Florida Division of Historical Resources (FDHR) and the US Army Corps of Engineers (Corps) directly. Gulf Power will provide the Management Summaries for each site electronically to the Corps for their submittal to and review by the Poarch Band of Creek Indians and the Seminole Tribe of Florida. Per *Section I: Timeframes and Review Procedures,* the Consulting Parties have thirty (30) calendar days to provide their comments back to the Corps.

If a "no historic properties affected" or finding of "no adverse effect" is made and there are no objections or revisions to the consultant's Management Summary recommendations, Gulf Power anticipates that the Corps will provide notification that construction of the structures within the evaluated site locations can begin within ten (10) calendar days of the NRHP eligibility determination made by the Corps. For sites determined to not meet the NRHP criteria for eligibility, matting across the site area during construction will not be considered necessary. For all NRHP-eligible sites and for those sites for which the NRHP remains undetermined, matting will be installed to access and install the transmission structures per Gulf Power's agreement to avoid to the extent possible ground-disturbing project related activities within the site boundaries.
