Good morning. As a part of the approval of geotechnical investigations within Torreya State Park associated with the overall North Florida Resiliency Connection (NFRC) project, the Florida Department of Environmental Protection's Division of Recreation and Parks (DRP) included a special condition that requires Gulf Power Company (GPC) to reach out to your office "to determine if a certified archaeological monitor is required to be on-site during any ground-disturbing activities."

We've discussed the timeline regarding the activities associated with the geotechnical investigations within the park and have determined that these activities could take more than just a couple days to complete. While there were no archeological sites found within the park, GPC will commit to contracting with a certified archaeological monitor to oversee these activities for the duration of the geotechnical investigation activities within the park. Please respond and acknowledge that GPC will

be providing an archaeological monitor for the duration of geotechnical activities within the park.
