I know that Brian Yates has been working with you concerning the cultural resources on the North Florida Resiliency Connection Transmission Line project for the NEPA portion; I'm working with the Florida DHR and the USACE Jacksonville District on the Section 106 agreement documents. Since it appears that we're not going to be able to complete all of the surveys (due to some hold-out landowners), we're opting for a Programmatic Agreement rather than an MOA. It is my understanding that you're only involved with a very small segment of overall project, and the cultural resource concerns for those segments is not complex.
