Hi Rich,

I just wanted to add that you may want to address the protocol for the “No access” properties that are either high or med probability, or the most viable portion of a low probability zone that must actually be tested to some degree. E.g. If the report is submitted without their being tested, when they become accessible, addendum report will need to be submitted for review before a full project determination of effect can be provided.

Otherwise I think the summary is accurate. And as with every project, justify the reasoning behind the decisions in the report narrative and our office is able to be relatively flexible – we just have to understand the thought process and factors that went into the decision. Have a great day!
