Hi Benny,

My review of those reports was completed when I sent my determination of effects (DOE) letters to the STOF on 3/5/21 requesting their review. The Corps concurred with all the work and recommendations in those reports. The STOF's subsequent concurrence with the Corps' DOE letters was received on 3/19/2021. Larry (Poarch Creek) had already submitted review/concurrence letters to the Corps for those reports on 3/5/21 having received them directly.

It was my understanding based upon verbal discussions that each party to the PA would be reviewing the extra work submittals as they are received, for the sake of timeliness. However, I may have been mistaken as SHPO was apparently waiting on the Corps DOE letters prior to beginning their review of the reports. This, of course, is what is specified in the PA, but I was under the assumption that the verbal discussions implied the reports would be reviewed asap regardless of the DOE letter from the Corps. This is why the additional survey reports have not been fully reviewed by the SHPO at this point. The SHPO has now received a DOE letter from us.

All that being said, all other testing management summaries are on time following the PA specifications.
